

US AND CANADA OFFICIAL CONTEST RULES

Canada (excluding Quebec)
ELECTRIC BIKE PULL TAB CONTEST

NO PURCHASE NECESSARY TO ENTER OR WIN. OPEN TO CANADIAN RESIDENTS, EXCEPT FOR RESIDENTS OF QUEBEC. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

Entry. NO PURCHASE NECESSARY TO ENTER OR WIN. Entry to the “E-bike Pull Tab” promotion begins on June 3, 2024, and ends at the close of business on June 30, 2024, or once a participating Trek Bicycle retail location is out of pull-tab cards (the “Entry Period”). A total of 100 pull-tab cards will be available per location.

The contest is sponsored by Trek Bicycle Canada, ULC (the “Sponsor”).

To participate in the contest and receive a pull-tab card while supplies last, visit a participating Canadian Trek retail location, approach a store representative, and test ride an electric bike.
